In consideration for being permitted to use Pinon Park Pool Association (PPPA) pool and facilities, the undersigned PPPA membership owner on behalf of him/herself, on behalf of all minors listed on member's membership, and on behalf of all guests of member's membership, and the undersigned adult(s) (age 18 or older as of 5/30/21) included on the member's membership, acknowledge and voluntarily agree to the following:

All persons using Pinon Park Pool Association (PPPA) pool and facilities shall strictly abide by all policies and rules regarding PPPA swimming pool and facilities specified on the PPPA website (www.PinonPool.com) and as specified at Pinon Park Pool by signage or as instructed by any PPPA officer, board member, or employee.
2. All persons using Pinon Park Pool Association (PPPA) pool and facilities recognize the inherent dangers in use of the facilities and hereby assume all of the risk of using the swimming pool and facilities and hold harmless the PPPA, its members, officers, board members, and/or employees from any and all liability actions, demands, damages, expenses, costs, claims, and causes of action of any nature with respect to injury, including death, loss or damage to self including but not limited to, children, guests, and all others, and/or personal property however caused as a result of or in any way related to the use of the swimming pool and facilities, including all areas around the pool, premises, and parking lot;

All persons using Pinon Park Pool Association (PPPA) pool and facilities agree to indemnify and hold harmless the PPPA, its members, officers, board members, and/or employees from and against any liability incurred as a result of or in any manner related to the use of the swimming pool and facilities, including all areas around the pool and premises, including but not limited to, the parking lot, sidewalks, entrances, and exits;
4. Photo release. Pinon Park Pool Association (PPPA) is hereby authorized to utilize any and all photographs, pictures, videos, or other likenesses of any persons, property, or any other thing located under #3 hereinabove, whether or not same is using Pinon Park pool and facilities, as PPPA deems appropriate in promotional material.
